EVENT'S CONDITIONS OF ENTRY

- 1. The City Toyota MTC Timed Round Robin Event is open to members and guests.
- 2. Competitors may enter up to a maximum of two events one from Group A and one from Group B.
- 3. The entry fee for this event is a gold coin donation.
- 4. The event will be held on Saturday 18 April 2020 from 1pm onwards.
- **5.** All participants will be expected to sign in **at least 20 minutes** prior to their first scheduled match.
- 6. Matches will be played on both hard courts and synthetic grass courts.
- 7. Where possible, each team will be placed in a group of 4.
- 8. Each match will last approximately 20 minutes (start and stop play on the bell).
- **9.** Participants will play in an alternate timed fashion (Group A, Group B, Group A) meaning there will be a gap between matches.
- **10.** The event will utilise a handicap format where the team trailing will start with a game advantage. E.g. If you're one game behind you start 15-0 up. The maximum you can go is 40-0 up. If you're four games behind, you automatically win the next game.
- **11.** Matches will play short deuces with a deciding point played at 40-40. For men or ladies' doubles, it will be receiver's choice. If it's mixed doubles, the male must serve to the male and the lady must serve to the lady.
- **12.** The winning team must report the score to the registration desk at the end of the match. If it's a draw, ensure one team reports the score.
- 13. Group winner will be decided based on number of points (Win = 2points and Draw = 1 point). If equal number of points, it will be decided on countback in the following order (Number of wins, Games won vs Games loss difference, Games won, Head-to-head match-up and finally number of draws). If all fails, a toss of the coin will be used to decide the winner.
- 14. The Event Director reserves the right to cancel or change any event if there are insufficient entries.
- **15.** The Event Director will inform all players of the match schedules. These will be posted at the club and will also be emailed to the nominated email address provided.
- 16. The Event Referee shall handle all disputes.
- **17.** The Event Director reserves the right to refuse any entry.
- **18.** Any NetSpark MTC Club Championships tournament finalist may be withdrawn from the event at the Event Director's discretion

Presentations will take place after the last Club Championship final on Saturday 18 April 2020.
